## Conditions of agreement

### 1 Definitions

- 1.1 For the purposes of the contract and these conditions, unless the context indicates to the contrary:
- 1.2 "Driver" means an employee of Delivery Group, whom is in possession of a valid pdp licence; "Effective date" means the first day on which the child will be making use of the transport services.
- 1.3 "Motor vehicle" means the vehicle that will be used by Delivery Group to transport the child as agreed between the parties; "Parent" means the guardian of the minor child / children.
- 1.4
- 1.5 "Pick-up location" means the place where Delivery will pick the child up and will include the place where each child will be dropped off after school, which location will be agreed upon by the parties before the effective date.
- 1.6 "Time of pick-up" will mean the time at which the child must be at the pick-up location, which will be agreed upon between the parties before the effective date.
- 1.7 "Time of drop-off" means the time at which the child will be dropped off and must be collected by the parent and / or person authorised by the parent to collect the said child, which time will be agreed upon between the parties before the effective date.

### 2 Payment

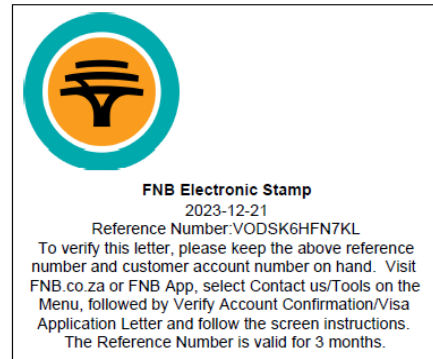
